

What Parents & Carers Need to Know about

MONEY MULING

Money multing involves individuals areny frequently young people a being recruited to transfer flegally obtained funds into and our of their bank account on behalf of criminals (often without even realising the fifth sind at activity they've become embroiled in), and usually being allowed to keep a criticing amount for themselves it is excentially a digital form of manay foundating. This guide big highes come of the risks associated with money multiply and provides parents and carrie with useful tips to help safeguard young people against becoming answared by this growing online hazard.

WHAT ARE THE RISKS?

LEGAL REPERCUSSIONS

Young people may be lund by the promise of quick, easy money, but by doing so they will become unwriting participants in activities thus can have severe legal and linearcial canequences. POSSIBLE EXPLOITATION

Money muting is frequently context out in bondern with other organised criminal activities such as the drugs trade or human trafficking. FINANCIAL LOSSES

if they (even unknowingly) transfer hands that are traced back to criminal activities, mandy mules can loce considerable financial losses: cheir bank may freste their accounts, and they pan be held liable for any Blegathy shalahed hands, reopie involved in money muling eften also find themselves at greater risk of becoming entangled in other forms of criminal financial excelutions.

LONG-TERM CONSEQUENCES

Involvement in money multing can have a leating regative impact on a young person's reputation, education and employment prospects, and place colorest streen on their family life. A conviction for financial fraud would significantly domage a young person's future opportunities; they could be blocked from opening a bank account, taking out a mortgage or even securing a bank account.

Advice for Parents & Carers

EDUCATE AND COMMUNICATE

rais to your child about the risks and consequences of money muling, emphasising the importance of motion informed decisions and seeking guidance if they need it. Create an open, non-judgmental space which encourages them to share their concerns and experiences, ensuring they lest comfertable getting help if they suspect they may have become involved in money muling.

MONITOR ONLINE ACTIVITIES

If you have concerns, you might want keep a classe than usual eye on your child's online presence, including their profiles on social media and any garring plotforms that they use. These can often serve as useful early warning systems which might help you to detect any signs of attempted recruitment by criminals or other types of supplicious behaviour.

TALK ABOUT MONEY

Discussions about evoiding being recruited as a money mule are also good opportunities for a refresher with your child about financial responsibility and good money management. It's also a height starting point for highlighting the importance of earning their money by honest means and the potential consequences of getting involved in illegal activities, both online and offers.

STAY INFORMED

Criminals' methods and approaches to recruiting young people as money mules frequently evolve to reflect the online landscape. Try to stay oware of criminals' current tactics and make time to regularly check out resources provided by schools, law enforcement and financial organizations. IMPORTANT LETTER ABOUT TAKING CHILDREN OUT OF SCHOOL DURING TERM TIME

Dear Families of Monksdown,

Monksdown Primary School is determined to do everything they can to ensure your child has the very best start in life. An essential part of this is that every child is punctual and attends school. As a parent or carer, you have an important part to play. Your child has the right to a good education and **you** have a legal responsibility to ensure that they go to school on time, all of the time.

Pupils should only be absent from school if:

They are too ill to attend

They have a medical appointment that can't be arranged out of school hours

There are exceptional circumstances

Advanced permission has been granted from school

Leave of Absence during term time:

Parents/Carers do not have a right by law to take their child on holiday during school term-time.

Only in exceptional circumstances may school grant leave of absence for a holiday. A written application to the Head Teacher or myself, Chair of Governors, must be made in order for the school to consider this. If a parent/carer takes a child on holiday without prior permission from the school, the Local Authority may issue a Penalty Notice of £120 per child, reduced to £60 if paid within 21 days. Even if a leave of absence is permitted it still counts as an absence and is recorded as Unauthorised. Permission simply means a fixed penalty will not be issued.

If you are experiencing issues with your child's attendance the school's attendance team are there to support. Please contact the school should you require their help.

Dear Parent or Guardian

The Summer HAF programme starts on the 24th July and there are lots of great activities happening over the school holidays. Children and young people, from reception to age 16 (including year 11 leavers), who are eligible for benefits related free school meals, will be able to access hundreds of activities throughout the summer holidays including specific provision available for children with SEND or additional needs, at no cost. There's a great range of activities across the city including boxing, football, music, dance, cycling, cooking, discos, films, basketball, arts and crafts, drama, bbg's, water games, trips out and much more! Every day there will be a range of fabulous meals available with many schemes holding family events as well.

When you have chosen an activity, you will need to contact that organisation to book a place. Each organisation will have either a telephone number, email address or online booking system. If your child has any additional needs or dietary requirements, then please discuss this with the organisation when you book. There is no central booking system so please read the details of the programmes on the website and ring the providers directly.
