What Parents & Carers Need to Know about

AI VIRTUAL FRIENDS

WHAT ARE THE RISKS? Artificial Intelligence — particularly in terms of how it generates natural language — has seen significant development over the last six months with companies releasing new Artificial common or or odding on Artificial to existing apps (such as Snepchot for example). has been the Ai friend or chatbot, as children eagerly experiment with these new found of computer generated companions. There are now numerous apps available with this virtual friend functionality, with the likelihood of it being added to other successful plotforms soon.

CONTENT AND ACCOUNTABILITY

All chatbots may not always be able to recognize when content is age inappropriate or harmful and chauld be littered out. So there's a possibility that children could be exposed to aftersive language or explicit material while conversing with their virtual friend. The companies producing such All solutions are also unlikely to take responsibility for any content that their alcorithms conerate.

REDUCED SOCIAL CONTACT

An excessive refence on chatbots for social interaction could potentially cause a child to begin reducing the amount of face-to-face communication they have, leading to social isolation. If young people become dependent on chatbots to provide companionship, it could very likely hinder the development of their reduition and of their reduitions.

LACK OF SENSITIVITY

Chatbot software isn't always sophisticated enough to pick up en subtle emotional cuas or recognise signs of distries in children, as most humons would. It might therefore tall to respond appropriately. Al misinterpreting what it's being told or replying insensitively to a young user who's already struggling could patentially impact a child's emotional wellbeing or exacerbate any saleting emotional issues.

PRIVACY CONCERNS

Chatbots typically collect data about users, including personal information and conviersations. 

IMPORTANT LETTER ABOUT TAKING CHILDREN OUT OF SCHOOL DURING TERM TIME

Dear Families of Monksdown,

Monksdown Primary School is determined to do everything they can to ensure your child has the very best start in life. An essential part of this is that every child is punctual and attends school. As a parent or carer, you have an important part to play. Your child has the right to a good education and **you** have a legal responsibility to ensure that they go to school on time, all of the time.

Pupils should only be absent from school if:

They are too ill to attend

They have a medical appointment that can't be arranged out of school hours

There are exceptional circumstances

Advanced permission has been granted from school

Leave of Absence during term time:

Parents/Carers do not have a right by law to take their child on holiday during school term-time.

Only in **exceptional circumstances** may school grant leave of absence for a holiday. A written application to the Head Teacher or myself, Chair of Governors, must be made in order for the school to consider this. If a parent/carer takes a child on holiday without prior permission from the school, the Local Authority may issue a Penalty Notice of £120 per child, reduced to £60 if paid within 21 days. **Even if a leave of absence is permitted it still counts as an absence and is recorded as Unauthorised. Permission simply means a fixed penalty will not be issued.**

If you are experiencing issues with your child's attendance the school's attendance team are there to support. Please contact the school should you require their help.

Dear Parent or Guardian

The Summer HAF programme starts on the 24th July and there are lots of great activities happening over the school holidays. Children and young people, from reception to age 16 (including year 11 leavers), who are eligible for benefits related free school meals, will be able to access hundreds of activities throughout the summer holidays including specific provision available for children with SEND or additional needs, at no cost. There's a great range of activities across the city including boxing, football, music, dance, cycling, cooking, discos, films, basketball, arts and crafts, drama, bbg's, water games, trips out and much more! Every day there will be a range of fabulous meals available with many schemes holding family events as well.

When you have chosen an activity, you will need to contact that organisation to book a place. Each organisation will have either a telephone number, email address or online booking system. If your child has any additional needs or dietary requirements, then please discuss this with the organisation when you book. There is no central booking system so please read the details of the programmes on the website and ring the providers directly.
